Dear LTC Shirley:

The Texas Commission on Environmental Quality (TCEQ) received your Final Report dated October 29, 2002 indicating that closure activities have been completed in accordance with the TCEQ Risk Reduction Standard (RRS) No. 1 pursuant to Title 30 Texas Administrative Code (TAC) Chapter 335 Subchapters A and S.

In order to attain RRS No. 1, all industrial solid waste and municipal hazardous waste and waste residues must be removed or decontaminated from affected media (i.e., soil, surface water, groundwater, air) to naturally occurring background levels or the Practical Quantitation Limits (PQL), provided that the person demonstrates that lower quantitation limits are not possible when PQLs are greater than background.

The TCEQ has completed a review of the Final Report. Based on the information contained in the Final Report and other information available to staff, it appears that cleanup at AOC 43 has attained RRS No. 1. The .6 acre tract of land within AOC 43 is released from deed recordation and post-closure care requirements.

Please be aware that it is the continuing obligation of persons associated with a site to ensure that municipal hazardous waste and industrial solid waste are managed in a manner which does not cause the discharge or imminent threat of discharge of waste into or adjacent to waters in the state, a nuisance, or the endangerment of the public health and welfare as required by 30 TAC §335.4. If the actual closure fails to comply with these requirements, the burden remains upon Camp Stanley to take any necessary and authorized action to correct such conditions. A TCEQ field inspector may review your Final Report and conduct a closure inspection of the site.
