
Dear LTC Shirley:

The Texas Commission on Environmental Quality (TCEQ) received the report entitled *Hydrogeologic Conceptual Site Model for Camp Stanley Storage Activity*, dated January 2006. The hydrogeologic conceptual model makes use of stratigraphy information from numerous monitor wells, rainfall data, groundwater and contaminant plume data and on and off-site groundwater withdrawal information collected site-wide since 1991 to explain and simulate how contaminant transport and migration patterns occur at CSSA. The TCEQ has reviewed the conceptual model and concurs with the report. The report is very informative and it presents another level of understanding to the complex nature of contaminant transport in a karst environment. The undersigned appreciates the all efforts Parsons and CSSA have contributed in the success of the report.

With regard to the report's recommendation of: 1) installing additional 2-inch wells at the Lower Glen Rose within the southern, eastern, northwestern portion of the facility, 2) installing gauging stations along Salado, Leone and Cibolo Creeks, 3) installing gauges to measure municipal groundwater withdrawal, and 4) delineating further Plumes 1 and 2, the final determination and decision for these recommendations reside with CSSA. However, the TCEQ will concur with the approval of any recommendation that will ultimately protect off-site users of the groundwater.
