The Texas Commission on Environmental Quality (TCEQ) received a status update request concerning AOC63 during the meeting at Camp Stanley on July 29, 2010. Herewith are TCEQ findings regarding AOC63:

- 1. Affected Property Assessment Report (APAR) for AOC63 was received on October 22, 2008.
- 2. A TCEQ letter dated February 26, 2009, commented and requested additional information pertaining to the APAR.
- 3. On July 29, 2009, the TCEQ conditionally approved the APAR, following receipt of Camp Stanley's letter dated May 27, 2009. The TCEQ's conditional approval was contingent on Camp Stanley's satisfactorily responding to the comments of Mr. John Wilder. The comments (contained in an InterOffice Memorandum dated February 5, 2009) pertained to his review of the Ecological Risk Assessment.
