



# Camp Stanley Storage Activity Environmental Program Information FACT SHEET

No. 9 – August 2002

*The purpose of this fact sheet is to provide an overview of information available to promote additional education of the general public regarding on-going groundwater sampling, site investigation, cleanup activities, and other environmental programs at Camp Stanley Storage Activity (CSSA).*

## Public Information

In an effort to keep the public, media, and others abreast of activities being performed at CSSA information has been made available in hard copy and electronic formats. The hard copy repository of information is called our “Environmental Encyclopedia.” The electronic version of this encyclopedia is available on a newly created website.

## Environmental Encyclopedia

While the environmental program and associated activities have grown over the years, it became clear that large amounts of data had been and were to be generated. In an effort to organize this data, CSSA created what is known as the “Environmental Encyclopedia.” This six-volume set of binders houses information regarding the environmental program actions as they are initiated and findings from previously completed ones. The binders are updated at least quarterly, to ensure that the most up-to-date information is available for public use.

The Environmental Encyclopedia is located behind the reference desk in the Government Documents Section on the 2<sup>nd</sup> Floor of the downtown San Antonio Public Library, 600 Soledad Street, San Antonio, Texas. Copies of this data have also been provided to the Texas Natural Resource Conservation Commission (TNRCC) at their San Antonio Regional Office located at 14250 Judson Road in northeastern part of San Antonio, as well as their Central Office in Austin, Texas.

The document is formatted for easy use by the reader, and is divided into the following volumes:

- **Volume 1 – Scoping Documents**

Plans and information including background information, correspondence, current conditions, work plans, site maps, field sampling plans, quality assurance plans, laboratory audits, and health and safety plans for work at CSSA. This volume also includes Fact Sheets and the Community Relations Plan.

- **Volume 2 – Background Metals Levels**

Information including background metals and soils types at CSSA and a statistical analysis of background metals levels at the site.

- **Volume 3 – Investigation Reports**

Chronologies, maps, and investigation results for solid waste management units, areas of concern, and rifle management units located at CSSA.

- **Volume 4 – Treatment Technologies**

Treatment tests, studies, and technologies used at CSSA.

- **Volume 5 – Groundwater**

Chronology of groundwater related environmental activities, quarterly groundwater monitoring reports, and groundwater investigation reports.

- **Volume 6 – Permits**

Permits and correspondence for permitting applicable to CSSA's environmental activities, such as air, hazardous waste, drinking water, and wastewater treatment systems under the Texas Pollution Discharge Elimination System, and other program areas.

## Electronic Environmental Encyclopedia

CSSA recently began hosting a website of the same information contained in the hard copy of the Environmental Encyclopedia. This data is available at [www.stanley.army.mil](http://www.stanley.army.mil). It is organized like its hard copy counterpart. The general public can access this information 24-hour a day and 365 days a year.

The website is updated approximately every quarter to provide the most recent information on the CSSA environmental program.

### **Other CSSA Fact Sheets**

CSSA has distributed nine other fact sheets since August 2001 to provide information about its' environmental program and groundwater monitoring activities. Copies of previous sheets are available in Volume 1 – 6 of the Environmental Encyclopedia or upon request – see contacts below.
