Subject: Sampling of Water Well JW-8, Located at 26531 Fawn Mountain Road

Dear Mr.

Camp Stanley Storage Activity (CSSA) collected groundwater samples from your well (JW-8) on 3/21/07. These samples were submitted to a laboratory contracted by CSSA's environmental contractor for volatile organic compound (VOC) analysis. This letter provides you with the VOC data from the laboratory results and a formal thank you for your assistance in this groundwater monitoring effort.

An abbreviated summary of analytical results compared to maximum contaminant levels (MCLs) allowed in drinking water by the U.S. EPA under the Safe Drinking Water Act is provided below:

\*The "F" qualifier indicates the value is above the laboratory method detection limit, but below the laboratory reporting limit for the compound.

Based on the analytical data, low levels of the VOCs PCE and *cis*-1,2-DCE were identified in water samples from your well. These levels are below the applicable MCLs and do not affect usability of your well.

As part of the ongoing CSSA environmental program, we are continuing to investigate and cleanup VOC source areas on the installation and to track these compounds in groundwater on- and off-post. As part of this effort, we may contact you in the future to schedule another sampling event for the well listed above.

Again, we would like to thank you for your cooperation. We regret that your well has been impacted, but remain committed to making sure your water is safe to use and keeping you informed.
