Dear LTC Shirley:

The Texas Commission on Environmental Quality (TCEQ) has reviewed the above-stated letter. Your letter pertains to the relocation and movement of non-hazardous lead impacted soils from SWMU B-8 and thereafter recycled and reused as berms at the East Pasture Firing Range. Your letter requests TCEQ's concurrence for this activity.

Based on our review, the TCEQ approves the relocation of lead impacted soils from SWMU B-8 for use as berms at the East Pasture Firing Range. This approval is, however, contingent on CSSA providing control measures that would mitigate any run-on and run-off from the firing range berms. Please note that the firing range and associated structures are subject to applicable closure requirements in 30 Texas Administrative Code Sections 335 and/or 350 during final closure.

Please be aware that it is the continuing obligation of persons associated with a site to ensure that municipal hazardous waste and industrial solid waste are managed in a manner which does not cause the discharge or imminent threat of discharge of waste into or adjacent to waters in the State, a nuisance, or the endangerment of the public health and welfare as required by 30 TAC §335.4. If the activities described in the report fail to comply with these requirements, CSSA shall take any necessary and authorized action to correct such conditions. A TCEQ field inspector may conduct an inspection of the site to determine compliance with the report.
