Dear LTC Shirley:

The Texas Commission on Environmental Quality (TCEQ) has reviewed the report entitled *Release Investigation Report Solid Waste Management Unit I-1* dated July 2008. The report requests the closure of Unit I-1 which includes Building 294 and the area surrounding the building. Building 294 includes an inactive incinerator. The incinerator was operational from 1943 to the late 60's and was reportedly used to burn classified documents. The report documented that concentrations of metals, volatile and semi-volatile organic compounds are below the action levels established by the TCEQ guidance, *Determining Which Releases are Subject to TRRP*, dated October 21, 2003. On the basis of information contained in the report, the TCEQ accepts the closure of Unit I-1.

Please be aware that it is the continuing obligation of persons associated with a site to ensure that municipal hazardous waste and industrial solid waste are managed in a manner which does not cause the discharge or imminent threat of discharge of waste into or adjacent to waters in the state, a nuisance, or the endangerment of the public health and welfare as required by 30 Texas Administrative Code (TAC) §335.4. If the activities described in the report fail to comply with these requirements, Camp Stanley Storage Activity shall take necessary and authorized action to correct such conditions. A TCEQ field inspector may conduct an inspection of the site to determine compliance with the report.
