Subject: Sampling of Water Wells RFR-3, RFR-4, and RFR-5,

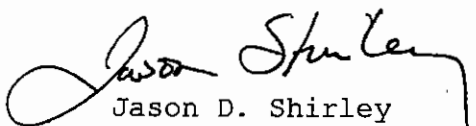
Camp Stanley Storage Activity (CSSA) collected groundwater samples from your wells (RFR-3, RFR-4, and RFR-5) on 3/10/04. These samples were submitted to a laboratory contracted by CSSA's environmental contractor for volatile organic compound (VOC) analysis. This letter provides you with the VOC data from the laboratory results and a formal thank you for your assistance in this groundwater monitoring effort.

Based on the analytical data, no VOCs related to CSSA's groundwater investigation were identified in water samples from your wells. Results from the laboratory analysis are provided as an attachment for the 3/10/04 event.

As part of the ongoing CSSA environmental program, we are continuing to investigate and cleanup VOC source areas on the installation and to track these compounds in groundwater on- and off-post. As part of this effort, we may contact you in the future to schedule another sampling event for your well listed above.
