Subject: Sampling of Water Wells FO-J1
and FO-17

Camp Stanley Storage Activity (CSSA) collected groundwater samples from your wells FO-J1 on 6/22/05, and FO-17 on 6/20/05. These samples were submitted to a laboratory contracted by CSSA's environmental contractor for volatile organic compound (VOC) analysis. This letter provides you with the VOC data from the laboratory results and a formal thank you for your assistance in this groundwater monitoring effort.

An abbreviated summary of analytical results compared to maximum contaminant levels (MCLs) allowed in drinking water by the U.S. EPA under the Safe Drinking Water Act is provided below:

*The "F" qualifier indicates the value is above the laboratory method detection limit, but below the laboratory reporting limit for the compound.

Low levels of the VOC PCE were identified in water samples from your well FO-J1. These levels are below the applicable MCL and do not affect usability of your well. No VOCs were detected in well FO-17. Results from the laboratory analysis are provided as an attachment for the 6/22/05 and 6/20/05 events.

As part of the ongoing CSSA environmental program, we are continuing to investigate and cleanup VOC source areas on the installation and to track these compounds in groundwater on- and off-post. As part of this effort, we may contact you in the future to schedule another sampling event for your wells listed above.
