Subject: Sampling of Water Well OFR-3, Located at 25617 Old Fredericksburg Road

Dear

Camp Stanley Storage Activity (CSSA) collected groundwater samples from your well (OFR-3) on 12/20/05. These samples were submitted to a laboratory contracted by CSSA's environmental contractor for volatile organic compound (VOC) analysis. This letter provides you with the VOC data from the laboratory results and a formal thank you for your assistance in this groundwater monitoring effort.

An abbreviated summary of analytical results compared to maximum contaminant levels (MCLs) allowed in drinking water by the U.S. EPA under the Safe Drinking Water Act is provided below:

*The "F" qualifier indicates the value is above the laboratory method detection limit, but below the laboratory reporting limit for the compound.

Based on the analytical data, the VOCs PCE and TCE were from samples your well. identified in water In addition, concentrations of dichlorodifluoromethane (0.54F ppb) were identified in your well. The U.S. EPA does not have a regulatory MCL established for dichlorodifluoromethane. Results from the laboratory analysis are provided as an attachment for the above sampling event. The results in December are below the MCL and do not prevent the use of your well. However, in the past the concentrations reported for VOCs were above the MCL. Therefore, a filtration system was installed on your well.

As reported previously, the filtration system was installed by Carbonair Environmental Systems of San Marcos, Texas. The system will remain in operation for the foreseeable future or until significant reductions in contamination levels are seen in the water in your well before it enters the filtration system. As we discussed at the time of installation, CSSA will be responsible for all costs associated with operation and maintenance of this system. CSSA will send a representative on a monthly basis to exchange the five-micron pre-and post-filters in the system.

Carbonair performed maintenance on the system in January 2006. Maintenance will be scheduled approximately every six months. Carbonair will exchange the first carbon canister and perform other routine maintenance operations at each six-month visit. If you experience any problems with the system, please let the installer or CSSA know immediately. Carbonair is very responsive and can make additional maintenance visits if needed.

As part of the ongoing CSSA environmental program, we are continuing to investigate and cleanup VOC source areas on the installation and to track these compounds in groundwater on- and offpost. As part of this effort, we may contact you in the future to schedule another sampling event for the well listed above.

Again, we would like to thank you for your cooperation. We regret that your well has been impacted, but remain committed to making sure your water is safe to use and keeping you informed.
