Dear Mr. & Mrs.

Camp Stanley Storage Activity (CSSA) collected groundwater samples from your well (JW-14) on 3/22/07. These samples were submitted to a laboratory contracted by CSSA's environmental contractor for volatile organic compound (VOC) analysis. This letter provides you with the VOC data from the laboratory results and a formal thank you for your assistance in this groundwater monitoring effort.

An abbreviated summary of analytical results compared to maximum contaminant levels (MCLs) allowed in drinking water by the U.S. EPA under the Safe Drinking Water Act is provided in the table below. All analyte concentrations were below MCLs, so they do not affect the usability of your well.

*The "F" qualifier indicates the value is above the laboratory method detection limit, but below the laboratory reporting limit for the compound.

Based on the analytical data, low levels of the VOC PCE were identified in water samples from your well. This concentration is below the MCL and does not prevent usability of your well. Results from the laboratory analysis are provided as an attachment for the event included in the summary table above.

As part of the ongoing CSSA environmental program, we are continuing to investigate and cleanup VOC source areas on the installation and to track these compounds in groundwater on- and offpost. As part of this effort, we may contact you in the future to schedule another sampling event for the well listed above.

Again, we would like to thank you for your cooperation. We regret that your well has been impacted, but remain committed to making sure your water is safe to use and keeping you informed.
