SUBJECT: Sampling of Water Well RFR-9, Located at 26109 Ralph Fair Road

Camp Stanley Storage Activity (CSSA) collected groundwater samples from your well (RFR-9) on 12/21/09. These samples were submitted to a laboratory contracted by CSSA's environmental contractor for volatile organic compound (VOC) analysis. This letter provides you with the VOC data from the laboratory results and a formal thank you for your assistance in this groundwater monitoring effort.

Based on the analytical data, no VOCs related to CSSA's groundwater investigation were identified in water samples from your well. Results from the laboratory analysis are provided as an attachment for the above sampling event.

As part of the ongoing CSSA environmental program, we are continuing to investigate and cleanup VOC source areas on the installation and to track these compounds in groundwater on- and off-post. As part of this effort, we will contact you in March 2010 to schedule another sampling event for the well listed above.
