The Texas Commission on Environmental Quality (TCEQ) received the report entitled *Description of Proposed Action and Alternatives - Road Construction*, dated May 2006. The report specifies that prior to any road construction and/or expansion, addition or widening, an Environmental Assessment is necessary in compliance with the National Environmental Policy Act of 1969 (42 U.S. Code 4321-4327). CSSA is currently preparing the Environmental Assessment to analyze potential environmental impacts of the road widening and other alternative action. CSSA is requesting TCEQ to identify specific issues or topics of environmental concern (to include potential permits or other requirements) that should be addressed in the Environmental Assessment.

The TCEQ has reviewed the report, the TCEQ does not have any comment regarding CSSA's proposal to widen existing perimeter and interior roads with the associated improvement of drainage ways of these roads. No TCEQ industrial or municipal hazardous waste permit requirements are required for this action. The TCEQ suggests that if CSSA discovers new and unreported contamination during the course of road expansion that this discovery be reported, within 24 hours of discovery, to the TCEQ Region 13 Region Office in San Antonio and to the Environmental Cleanup Section II, attention to the undersigned.
