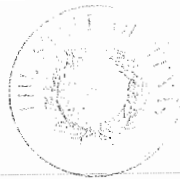

The Texas Commission on Environmental Quality (TCEQ) has received the above-stated letter written in response to TCEQ letter dated February 26, 2009. The TCEQ letter requested additional information and/or comments regarding the report entitled *Affected Property Assessment Report (APAR) for Area of Concern (AOC) – 63*. To summarize, the TCEQ letter requested additional information and/or comment on the following items: 1) Sample Quantitation Limits and critical Protective Concentration Levels, 2) exceedance of hold times for explosives constituents, 3) perchlorate tests, and 4) potential for low level concentrations of Chemical of Concern impacting ecological receptors. Item No. 5 forwards the comments of Mr. John Wilder, TCEQ Technical Support Team, regarding the Ecological Risk Assessment portion of the APAR.

The TCEQ has reviewed your response letter. Our review indicates that CSSA has satisfactorily responded to the request for additional information and/or comments as itemized in TCEQ letter dated February 26, 2009. The TCEQ is, however, deferring the approval of the APAR until Mr. Wilder concludes his review of CSSA's response letter.
