Dear Mr. Shirley:

The Texas Commission on Environmental Quality (TCEQ) has completed the review of the above mentioned report. AOC-42, AOC-52, AOC-58, and AOC-62 have a total area of approximately 3.8 acres. Metals and munitions were identified at all the AOCs which include mainly small arms, rocket launchers, radios and munitions debris.


Soil sampling conducted at the AOCs was analyzed for VOCs, SVOCs, and metals. All locations (mainly trenches) where debris was encountered were excavated, and confirmation samples taken. A total of approximately 5,900 cubic yards of soil was excavated. All confirmation samples were below the Tier 1 PCLs except methylene chloride in three samples which are believed to be from laboratory contamination. The Salado Creek Area passes the Ecological Exclusion Criteria Checklist.

CSSA requests no further action for AOC-42, AOC-52, AOC-58, and AOC-62. Based on the information contained in the report, the TCEQ agrees that no further action for AOC 42, AOC-52, AOC-58, and AOC-62 is needed. CSSA currently has approximately 88 on-site and off-site groundwater monitoring wells monitoring two chlorinated solvent plumes which originated from two sources not related to AOC 59.
