The Texas Commission on Environmental Quality (TCEQ) has completed the review of the above mentioned report. SWMU No. 27 is approximately 2.0 acres in size, consisting of eight waste disposal trenches containing mainly munitions debris. Approximately 9,130 cubic yards were excavated and removed from the trenches, and confirmation samples were taken. Additional excavation was conducted on August 22, 2011 due to the exceedance of barium, copper, and zinc (404.0 mg/kg, 178.43 mg/kg, and 341.4 mg/kg respectively) and further confirmation sampling was conducted.

Based on the final confirmation sampling, no metals were detected above their respective PCLs or background concentrations when used as the PCLs. CSSA requests no further action for SWMU No. 27. Based on the information contained in the report, the TCEQ accepts the no further action for SWMU No. 27.

CSSA currently has approximately 88 on-site and off-site groundwater monitoring wells monitoring two chlorinated solvent plumes which originated from two sources not related to SWMU No. 27.
