Dear Mr. Shirley:

The Texas Commission on Environmental Quality (TCEQ) Underground Injection Control (UIC) Permits Section staff has completed review of the request dated August 7, 2017 to combine Class V injection well authorizations 5X2600408 and 5X2600431 at the Camp Stanley Solid Waste Management (SWMU) B-3 site. To satisfy your request, Class V authorization 5X2600431 will be amended to add the injection wells and injectate authorized under Class V authorization 5X2600408, and Class V authorization 5X2600408 will be closed.

Based on our review, approval is hereby given for amendment to Class V Authorization 5X2600431 to include the following revisions:

- Addition of sodium lactate, emulsified vegetable oil (EVO), vinegar, Dry Acid Special and potassium iodide
- Addition of four injection wells (CS-B3-MW01 - 04)

The approved amendment is limited to that described by the application for amendment of the Class V Injection Well Authorization dated August 7, 2017. This approval revises the requirements and conditions of the authorization approved on July 20, 2006 and revised on June 25, 2007, July 31, 2008 and February 17, 2012 and should be attached thereto. In order to maintain authorization by rule for the injection operations, the project must meet all requirements set by the Remediation Division and the UIC rules provided by 30 Texas Administrative Code (TAC) Chapter 331.

Additionally, because the injectates and injection wells authorized under 5X2600408 are now being authorized under 5X2600431, UIC is closing Class V Injection Well Authorization 5X2600408. Accordingly, Class V Authorization 5X2600408 is terminated. This closure relates only to the termination of 5X2600408 and no other site remediation activities.
